- 1.) Your son's/daughter's teacher will need to sign this form indicating that he/she currently meets the necessary academic requirements.
- 2.) Prior to any tryouts/practice the rest of this form needs to be filled in and a parent/guardian signature must be affixed. The form needs to be returned to the teacher by Thursday, February 9, 2012. A \$ 40.00 charge per boy/girl to cover leagues fees.
- 3.) When the soccer season is over, the SPX uniform must be returned to SPX School. If the uniform is not returned to SPX in appropriate condition an additional \$ 40.00 fee will be assessed to cover the uniform's increased replacement cost.
- 4.) Discipline and/or grade problems during the course of the season may jeopardize your son's/daughter's position on the team.
- 5.) Please be sure that your son/daughter has read, signed, and returned the attached Code of Conduct form by Thursday, February 9, 2012.

## CENTRAL CITY & SOUTHBAY ATHLETIC LEAGUE CODE OF CONDUCT

If athletics are an extension of the education process and the Catholic philosophy we support, it is necessary for coaches, players, officials and spectators to make a concerted effort to maintain a decorum that is Christian. It is incumbent on all to act in a way that is reflective of this belief. The athletic field should be an extension of the classroom. It should teach. Primary to this purpose is the fact that learning is present in everything we do. Sportsmanlike behavior is a fundamental skill that must be learned and modeled by all.

A sportsmanlike person is defined as being "one who abides by the rules of the contest and accepts victory or defeat graciously." Athletes will perform as they are taught and expected to perform. Sportsmanlike behavior becomes a habit for all. Consistent instruction, attention and correction of behavior will result in a positive athletic experience. While sportsmanlike behavior is a complicated issue in itself, there are several qualities that educators, coaches, officials, players, and spectators should strive to accomplish:

1. All participants, coaches and spectators must be accountable for their actions; behavior that is not reflective of league philosophy must always be addressed.
2. The coach is always responsible for the behavior of his/her team and spectators.
3. Learning is a matter of experience and to this end the League is dedicated to participation. Every member of the team has the right to experience the challenge of athletic competition each and every game.
4. Actions by individuals that call attention to themselves are a distraction from the game and are therefore unacceptable.
5. Respect the privilege of using facilities that have been provided for our use by treating them as if they were ours.
6. Playing areas are out of limits for spectators who rightfully belong in the stands or in viewing areas apart from the boundaries in and the field or court.
7. The young people who enjoy the game deserve our wholehearted commitment to their safety.
8. Abide the rules of the game and the league in letter and spirit, regardless of what the outcome may be.
9. Always exemplify the highest moral character, behavior and leadership.
10. Respect the integrity and personality of the athlete – both your team and the opponents.
11. Display modesty in victory and graciousness in defeat.
12. Always respect the integrity and judgment of the officials; never bait or taunt an official in any way.

## CENTRAL CITY & SOUTH BAY ATHLETIC LEAGUES CODE OF CONDUCT

- **Conduct of Players, Coaches, and Spectators** – Each school is held accountable for the behavior of its coaches, players, and spectators. Should the actions, words or behavior of the school's players, coaches, or spectators not meet the standards set forth in the Leagues Code of Conduct, the school will be subject to leagues sanctions which may include but not be limited to: forfeiture of a particular game, immediate exclusion from participation in the remainder of the season, exclusion from the next season(s) sport(s), exclusion from future participation in League play.
- All participants, coaches and spectators must be accountable for their actions; behavior that is not reflective of leagues philosophy must always be addressed.
- The coach is always responsible for the behavior of his/her team and spectators.
- Actions by individuals that call attention to them are a distraction from the game and therefore are unacceptable.
- **Playing areas are out of limits for spectators who rightfully belong in the stands or in viewing areas apart from the boundaries in and around the field or court.**
- Always exemplify the highest moral character, behavior and leadership.
- Always respect the integrity and judgment of the officials; **never bait or taunt an official in any way.**

Each school must have an official faculty/staff member present at each game. This representative must identify his/herself to the head referee prior to the start of each game. It will be the role of this person to be sure that coaches, players, and fans' behavior reflect the League Code of Conduct.

There will be times when a coach or player feels victimized by what they believe an illegal act. In organized athletics, it must always be the referee who makes the on-field decision. While everyone is entitled to their perception, only the referee applies the rules of the contest. Their decision will be based on their observation. That is the way it must operate. Coaches, players, and fans must understand this fact.
