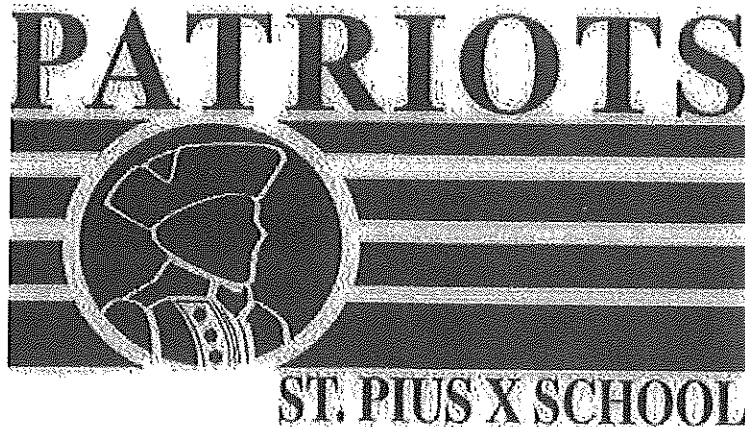

**FACTS (FAST AUTOMATIC CASH TRANSACTION SERVICES)**

The FACTS form explains tuition payment procedures. You will be given options for payment of tuition from how often in the year, to the day of the month, to the account from which the withdrawal will be made. Unless you are paying tuition in full – paid to St. Pius X School, families need to have a bank account for tuition withdrawals. The FACTS tuition management system is the **ONLY** way tuition will be paid and there is a \$41 annual withdrawal fee per contract from you account separate from regular tuition withdrawals. **Former FACTS users do not need to enroll online again – only new incoming families.** The recommendation for families who do not have any bank account is to open a children's account specifically for tuition withdrawal. **ALL MONTHLY PAYMENTS WILL START IN JUNE.** On the back of this form is a detailed schedule regarding the tuition.

**Registration Fee Per Student is \$250 and includes the following:**

- Student Accident Insurance
- ITBS Testing Fees
- Periodicals
- Consumable Materials and books

**PTG (Parent/Teacher Group) Dues are \$25 per family.**

**The Online FACTS bank information form is due upon registration.**

**The non-refundable fee of \$250 per student and the \$25 PTG dues are submitted when re-registration forms are due or in the case of new families, within 5 business days of student's acceptance. Money orders or checks made out to St. Pius X School will be accepted as well as major credit cards. All deadlines must be met in order for registration to be complete.**

Registration forms for the next school year will be available on the 1<sup>st</sup> day after St. Pius X School Christmas vacation (1/3/2012). It is important to complete this paperwork as close to the opening day as possible. Families with children listed on the form are invited to test, but this is not a guarantee of a position in the school. Grades 1-8 testing will be on Monday, March (3/5/2012) at 3:00 PM and there is a fee of \$30.00. Kindergarten assessments are scheduled individually.

Diocesan Age policy for Kindergarten & 1<sup>st</sup> grade - #505 – “A child must be five years of age by September 1<sup>st</sup> to be admitted to Kindergarten. A child must be six years of age by September 1<sup>st</sup> to be admitted to grade 1.”

The school will determine Kindergarten readiness on an individual basis. If a child shows significant readiness, the principal may meet with the parents and teacher to discuss the possibility of enrollment if the above-mentioned age requirement is a factor.

Kindergarten Admission – A child entering Kdg. must meet the age requirement above and be tested by the school for developmental readiness. The school will determine readiness on an individual basis. St. Pius X School will use a standardized screening process that is approved by the Diocesan office. This assessment will be administered by a qualified tester appointed by St. Pius X School at our school site. The results of this assessment will be the basis used:

\* to determine development readiness and

\* to determine acceptance into St. Pius X School kindergarten program, if a child meets the above stated age & readiness requirements.

For your information we use the Gesell test of developmental readiness to determine readiness for St. Pius x School kindergarten. These specific results, plus the age of the child are the criteria we use to determine placement in our Kindergarten. Assessments from other schools are not accepted.

Admissions for Grades 1-8: Students seeking admission to Grades 1-8 will be tested to determine the level of their basic skills, and to ascertain at which grade level they would be most successful. Incoming students will be placed at the grade level judged by St. Pius X School to be the best grade level for that particular student.

St. Pius X School also complies with the California law that requires a health checkup for school entry to protect the health of all children. The health check up can be given anytime during the year and a half (18 months) before your child begins first grade. All immunizations must be up to date for all students.

Admission Policy

Students who meet the above criteria are placed in the priority below:

- brother or sister of student presently enrolled in the school
- family is a verified registered contributing member of St. Pius X Parish
- date of enrollment form

To qualify as a contributing member of St. Pius X Parish, and to receive the reduced tuition rate you:

- must attend Sunday Mass at St. Pius X Church on a regular basis
- must use your envelopes weekly and contribute at least \$400 during the calendar year (Jan.–Dec.)

It is required that you meet this obligation with weekly Mass attendance and not in one lump sum in Dec. This is only \$7.69 per week! This means if you wish the contributing parishioner tuition for the next school year (2013-14) your family contribution must be \$400.00 by the end of December 2012.

Our school will not administer the test unless you are aware of this information.

**Parent Volunteer Hours** – Participation in volunteer time spent helping St. Pius X School and Parish. Thirty hours of volunteer service per family is required per calendar year (Jan.-Dec.).

**350 Program** – The 350 Program represents a creative approach to tuition reduction. Each family is required to generate a least \$350 of profit per year through various fundraising events or programs that directly benefit the school. Since all families benefit from these profits, the basic expectation is that all families will support these efforts. Families may participate in the \*e-Scrip, \*purchase SCRIP, \*purchase auction items at the annual school gala and golf tournament auction. Twenty-five percent of the money spent on auction items will be credited towards required profit commitment. (For example, if you spend \$100 on auction items, you will receive \$25 towards your profit requirement.)

**SCRIP Incentive** – Once a family earns the \$350 minimum in SCRIP rebates, they will share 50% of the profits earned above the \$350 minimum. If a family earns \$500 in SCRIP for the year, they will receive \$125 profit. Shared profit may be used toward tuition, registration fees, graduation fees/costs, camp and daycare accounts. Non-returning family or 8<sup>th</sup> grade family earning SCRIP credit over the required \$350 may use 50% of their share of profit over toward graduation fees/cost, tuition or daycare. All profits earned must be used in the school year in which it was generated. There will be no cash profit distributions.

**Registered Contributing Parishioner** – The family must be registered and on record at the parish office as having made financial contributions to St. Pius X Church in the amount of at least \$400 during the prior calendar year.

### Category D

### Category E

Families of new 8th grade students will receive Category B tuition, but if the following requirements are met: \$140.00 contribution to parish, \$117.00 profit in Scrip program and 12 parent volunteer hours by Dec. 31 2012 your tuition will be changed to Category A

Annual payment is due July 01, 2012 - Semi annual payment is due Jul 01, and Dec 01, 2012 to St. Pius X School or FACTS
